**Product Specification** . . . The Vari-Slab<sup>(TM)</sup> is a one piece, solid surface Deck with integral Basin(s). The Vari-Slab<sup>(TM)</sup> Deck is configurable with up to four integral Basins. Width of Deck must be specified. The unit is cast in opaque, polymer resin solid surface material. Decks include options Backsplash(s), Sidesplash(s) and/or Apron(s) unless specified otherwise.

The Deck can be configured for Mounting Carriers (-MC) which includes an arm/wall mounted Carrier appropriate for residential or light commercial applications. An optional commercial floor mounted Arm/Carrier (-MC-FLR) is available for heavier commercial application and requires a 2" x 6" wall construction. Both Carrier systems are concealed in the wall; therefore, installation must be

An Overflow Waste Channel is also integrated in the cast Basin, draining into the Drain assembly.
